#### 1 IP6X test

#### 1.1 Test procedure

- 1) The test wire of 1.0mm  $\Phi$  shall not penetrate and adequate clearance shall be kept.
- 2) The test is made using a dust chamber, the powder circulation pump may be replaced by other means suitable to maintain the talcum powder in suspension in a closed test chamber. The talcum powder used shall be able to pass through a square-meshed sieve the nominal wire diameter of which is 50 µm and the nominal width of a gap between wires 75 µm. The amount of talcum powder to be used is 2 Kg per cubic meter of the test chamber volume. It shall not have used for more than 20 tests.
- 3) If an extraction rate of 40 to 60 volumes per hour is obtained the duration of the test is 2 h.
- 4) If, with a maximum depression of 2 kPa(20 mbar), the extraction rate is less than 40 volumes per hour, the test is continued until 80 volumes have been drawn through, or a period of 8 h has elapsed.

# **1.2 Evaluation of test results**

- Acceptance conditions for the IP6X test:
- 1) The protection is satisfactory if adequate clearance is kept between the access probe and hazardous parts.
- 2) The protection is satisfactory if no deposit of dust is observable inside the enclosure at the end of the test.

## 2 IPX7 test

## 2.1 Test procedure

The test is made by completely immersing the enclosure in water in its service position as specified by the manufacturer so that the following conditions are satisfied:

- 1) The lowest point of enclosures with a height less than 850 mm is located 1000 mm below the surface of the water.
- 2) The duration of the test is 30 min.
- 3) The water temperature does not differ from that of the equipment by more than 5 K. However, a modified requirement may be specified in the relevant product standard if the tests are to be made when the equipment is energized and/or its parts in motion.

## 2.2 Evaluation of test results

In general, if any water has entered, it shall not:

- 1) Be sufficient to interfere with the correct operation of the equipment or impair safety.
- 2) Deposit on insulation parts where it could lead to tracking along the creepage distances.
- 3) Reach live parts or windings not designed to operate when wet.
- 4) Accumulate near the cable end or enter the cable if any.





Fig.9- Overall view of model MC05CXXXX series
















Fig.11- Overall view of model MC12CXXXX series
